An applicant may submit a separate silent/closed bid for each slip pool. However, any boat intended to be moored in a slip must meet the length and width requirements of that particular slip pool.

The name on this application will be the name of the lessee on the boat slip lease and must also be listed on the registration for the boat.

A boat slip lease can not be held in the name of a business. If the boat is registered to a family trust, the applicant must provide evidence they are listed in the trust.

Upon signing this application, the undersigned applicant acknowledges that he/she has fully read and understands the information on this application and the silent/closed bid rules on the reverse side of this form.

BEAR LAKE STATE PARK BOAT SLIP SILENT BID APPLICATION RULES

1. A boat slip silent/closed bid applicant must be at least 18 years of age.
2. Ownership of a boat is not required to submit a boat slip silent/closed bid application.
3. For the purposes of mooring a boat in the Bear Lake State Park Marina, the actual length of a boat may not be the length listed on the boat's certificate of registration. The measurement of the overall length of a boat must include all extensions from the bow, i.e. bow pulpits, to the stern, e.g. swim platforms, trolling motors, etc.
4. All boat slip silent/closed bid application fees are non-refundable, non-transferable, and non-applicable towards the payment of boat slip lease fees.
5. Applicants will be rank ordered on the respective boat slip silent/closed bid list according to the highest amount bid for the respective slip pool.
6. Specific bid information obtained from a silent/closed bid application will not be available for public inspection or review. The park manager and at least one other park staff member will have access to the bid information.
7. When a vacancy occurs for a boat slip allotted to be filled from a silent bid application, Bear Lake State Park will attempt to contact the applicant with at the top of the respective silent bid list by phone. Each phone number listed on this application will be called once. When contact is made, the applicant will have three (3) business days from the time of contact to accept or decline the offer to lease a slip. Contact is considered to have been made with a message left on an answering device.

If contact is made with the applicant and he/she does not accept the offer, the applicant will forfeit his/her position on the respective silent bid list and the next person on the silent bid list will be called.

If contact is not made with the applicant within three (3) business days, the applicant will forfeit his/her position on the respective silent bid list and the next person on the silent bid list will be called.

8. Applicants who accept an offer to lease a slip will be provided a dated Boat Slip Lease. The applicant will have 30 days to provide a completed and signed Boat Slip Lease, a copy of the boat's current Utah certificate of registration, and payment of the annual slip lease fees, to the Bear Lake State Park Marina office. The applicant will be assigned a specific boat slip once all required documentation and paperwork have been received by Bear Lake State Park. Failure to meet this deadline will result in the applicant losing his/her opportunity to lease a slip.
9. Current boat slip lessees who desire a different sized boat slip will be required to complete a boat slip waiting list application for the respective size slip.
10. Current boat slip lessees who purchase a boat that exceeds the size requirements of their assigned slip will be required to remove the boat from the marina and their current boat slip lease will be terminated.
11. Boat slip silent bid applications for the 2011 summer season will be accepted beginning September 6, 2010 and ending February 15, 2011. Each silent bid application shall include the appropriate fee and shall be delivered in an envelope addressed to:
