

## SPECIAL FUN TAG AFFIDAVIT

The Utah State Parks Special Fun Tag is issued to a Utah resident who meets one of the following criteria: 1) **Legally Blind**, which is defined as vision of 20/200 or less in the better eye with best correction, or a field restriction of 20 degrees or less in both eyes; or 2) **Non-Ambulatory**, which is defined as being permanently confined to a wheelchair or the use of a cane, crutches or mobility device, or who has lost either or both lower extremities.

To qualify as legally blind or non-ambulatory, a licensed ophthalmologist, optometrist, or physician must sign this Utah State Parks Special Fun Tag Affidavit verifying the disability, as defined above, is a permanent condition.

This permit provides free day-use entrance to all Utah state parks except This Is The Place Heritage Park, and does not cover the Davis County Causeway Fee at Antelope Island State Park.
