

Jordanelle State Park Announces 2010 Silent Auction and Random Draw Procedures Boat Slip/Dry Storage Acquisition

The Division of Utah State Parks and Recreation announces a silent auction and random draw process for boat slips and dry storage at Jordanelle State Park. The silent auction process will take place prior to the random draw.

- No more than half of the available slips per pool will be filled through the silent auction process, with no more than 31 of the 62 slips awarded to high bidders.
- For the silent auction, only minimum bids of 50% more than the current publicized State Parks fee schedule will be accepted. See table below.
- Successful recipients will receive a six-month contract from May 1 through October 31, 2010. Upon successful completion of the six-month contract (season), slip holders will have the option to renew for an additional six-month term (May 1 through October 31, 2011). The lease period is not to exceed two consecutive seasons, 2010 through 2011.

Applicants may choose to apply to both the silent auction and random draw processes. Successful recipients of the silent auction will be withdrawn prior to the random draw.

Applications for the boat slip silent auction and random draw processes will be available January 12, 2010 at www.stateparks.utah.gov or may be picked up at Jordanelle State Park, Hwy 40, exit Mayflower #8. Office hours are 10-5, Mon-Fri. To receive a mailed or faxed copy, call (435) 649-9540.

A non-fundable \$20.00 Application Fee must accompany all applications. Applications must be submitted in person or by mail, and must be **received (not just postmarked) by 5:00 PM, Friday, February 12, 2010 at the Jordanelle State Park Office.** *See location and address below. Any applications received after 5:00 PM, February 12 will not be considered and will be returned.

Notification of successful boat slip recipients will be made by 5:00 p.m. on March 1, 2010 and will be posted at www.stateparks.utah.gov. For additional information, please call Jordanelle State Park at (435) 649-9540.

Boat Slip/Dry Storage Silent Bid and Random Draw Procedures 2010

1. A person may submit only one application per registered boat. The applicant must be 18 years of age or older.
 - a. Corporations, trusts, partnerships, etc. that own more than one vessel can only submit one application that includes the name of one owner as the responsible party.
 - b. The responsible party agrees not to use the boat slip to conduct any type of commercial activity.
2. Only one application in the appropriate pool by boat length may be submitted per legally registered boat. Note: For the purpose of Boat Slip Applications, the LENGTH of your boat is not the registration length, but must include all extensions from the bow, i.e. bow pulpits, to the stern, e.g. swim platforms, trolling motors, etc.
3. Interested applicants who do not currently own a boat may apply. If applicant successfully receives a wet or dry slip, a new title of ownership and/or a notarized bill of sale with a current state of Utah registration will be required to complete their lease agreement prior to occupancy.
 - a. Prior to lease approval a ***Division of Motor Vehicle Records Check*** will be conducted.
4. No boat, other than the one assigned to a slip and owned by the lessee may occupy the slip without written permission from the Park Manager.
5. Annually, successful applicants who meet all boat slip or dry storage lease terms and conditions will be given an option to renew the lease for another season (May 1 thru Oct. 31). The last option to renew will be given for the 2011 season.
6. Application must be received (not just postmarked) by 5:00 PM February 12, 2010 at the Jordanelle State Park Office.
7. Successful slip recipients will be notified by 5:00 PM March 1, 2010. Results will also be posted at www.stateparks.utah.gov.
8. Successful applicants will be mailed a *Boat Slip Rental Lease* agreement and an invoice for the upcoming season of May 1st thru October 31st, 2010. No other attempt to contact an applicant will be made.
9. **Payment for the season must be received (not just postmarked) by 5:00 PM April 1, 2010 at Jordanelle State Park to avoid loss of slip/dry storage parking.**
10. Beginning April 12, 2010 at 9:00 AM, any person 18 years of age or older can be placed on the waiting list by submitting their information and required fee in person at Jordanelle State Park. A non-refundable fee of \$50.00 will be charged per waiting list applicant for the two year time period. All waiting lists will expire October 31, 2011. If a slip becomes available, the \$50.00 fee will be applied towards the lease payment.
11. Boat Owner may terminate the Lease at any time by giving thirty (30) days written notice.
12. Failure to follow the procedures will be reason to terminate a lease agreement or disqualify a person from participation in the random draw.
13. Successful wet slip applicants will be receiving a slip for their boat only. This does not include trailer parking. Please make other arrangements for your trailer. Trailers left behind may be towed at the owner's expense.
